



Incentives at HWCs

Performance Linked Payments

- PLP are being introduced at SC-HWCs for the team of the facility and the frontline health workers who are instrumental in providing comprehensive primary health care closer to community.
- The team's performance will be objectively assessed using specific indicators and the incentive amount will be based performance of whole team to achieve those indicators.

PLP: Process

Step-1: Self performance assessment

- To be done by
 - CHOs for SC HWC;
 - ANM for collocated SC of PHC-HWC and all virtual SCs under UPHC HWC; and
 - MO for PHC/U PHC level HWCs.
- The documentary proof for each such entry has to be attached with regards to performance as per the MOV.
- The appropriate authority for verification.
 - Appropriate Authority for SC level HWC MO I/c of concerned PHC
 - Appropriate Authority for virtual SCs under UPHC level MO I/c of concerned UPHC
 - Appropriate Authority for PHC/UPHC HWC MO I/c of concerned CHC/UCHC

PLP: Process

Step-2 Validation of Self Assessment Report

• Desk appraisal has to be done by the appropriate authority with the support of PMU as per the MOV suggested in the assessment format and documents submitted in response to that as proof.

Step-3 Third Party Evaluation

- Sample check will be done by third party engaged by competitive bidding process by the State.
- But payment of incentives should not await third party evaluation.

Performance & team based incentives

Performance linked incentive for CHO & MPWs at SCs

- CHO at SC-HWC: Rs. 15,000/- per month based on achievement in 28 indicators
- MPW at SC-HWC or Co-located SC with PHC or Virtual SC with UPHC: Maximum of Rs. 1,500/- per month per MPW per SC based on achievement in 27 indicators. In case there are 3 persons (Regular ANM, Additional ANM and MPW-M), then the incentive amount based on calculation shall be multiplied by 2 to arrive at the final incentive amount and then to be equally divided among all MPWs.
- ASHA at SC level HWC, co-located SC of PHC level HWC and virtual SC at UPHCs: a maximum up to ₹. 1000 per ASHA may be paid based on the achievement of the team in the 25 indicators
