

The proposals of following Agencies have been rejected due to not meeting the eligibility criteria mentioned against each one.

S.No	Name of the Agencies	Reason for rejection
1	Bharat Gyan Vigyan Samiti, Odisha	a) The Agency has total four years of experience. b) The Agency has only conducted three evaluations in last five years. c) No supporting documents submitted relating to Key Professionals for Evaluation team.
2	Gramin Vikas Trust	The Agency has only two fulltime evaluation team members as per information and documents provided in the proposal.
3	Pravati Health, Cuttack	The Agency is not meeting the eligibility criteria as mentioned in the EoI document i.e a) At least five years experience in conducting independent evaluation/ assessment in social development sector, b) Agency has conducted minimum five evaluations for any Government or Development Agencies in last five years. c) Agency has at least three fulltime experts/ subject specialist with more than five years of work experience in similar field that would conduct the evaluation/assessment.
4	Sambodhi Research and Communication Pvt. Ltd	The Agency has not submitted declaration that the Organization or any Office Bearers/Board of Directors are not Blacklisted in the mode of Affidavit from any authorised Body/Person.
5	Hara Gouri Welfare Society	a) The Agency has registered under the Society Registration Act 1860 before the Addl. Register of Societies, Sonapur. The NGO has not registered in the Office of the IGR-cum-Registrar of Societies, Odisha, Cuttack to work beyond one district. b) The Agency is not meeting the required eligibility criteria i.e experience in conducting evaluations and not having experienced evaluation team members.

7	DCOR, Bhubaneswar	The Agency has not submitted application in the prescribed format. Further, no supporting documents' relating to the experience and declaration in the mode of affidavit has been submitted by the Agency.
8	Sarva Seva Samiti Sanstha	The Agency does not have minimum five years experience as per requirement. Further, the Agency has only two fulltime evaluation team members with Master Degree Qualification against minimum requirement of three fulltime members.
9	IPOS, Haryana	Not secured qualifying mark in the Technical Evaluation.
10	Green India	Not secured qualifying mark in the Technical Evaluation.
11	Development Solutions	Not secured qualifying mark in the Technical Evaluation.
12	Sakti Sikha Development	Not secured qualifying mark in the Technical Evaluation.
13	SDRC, Bhubaneswar	Not secured qualifying mark in the Technical Evaluation.
