Sub: Maximum ceiling limit on award of contract to a particular NGO in the State out of OSH&FW Society Funds-regarding.

Madam / Sir,

In inviting a reference to the subject cited above, the State NGO Committee of OSH&FW Society, in its 37th meeting held on 18.09.2020 has determined a maximum ceiling limit on award of contract to a particular NGO as follows:

1. A maximum number of ten projects only which can be sanctioned to a particular NGO in the State out of OSH&FW Society Funds.
2. However, in case of non-availability of NGOs for new projects despite proper advertisement, the capping limit may be waived aside in such particular case only in order to ensure service delivery in the remote and difficult areas. However, during selection, the credibility of the NGO should be taken into consideration.

You are, therefore, requested to communicate the above norms to the existing partner NGOs at your level for their information. Further, during selection of NGOs for new partnership projects, above norms must be adhered to at your level.
