Different queries raised by the prospective bidders on the tender terms & condition, scope of work etc. were discussed. In response to the written queries by the prospective bidders, the clarifications /amendments as decided by the committee are mentioned below:

Hence medical screening is not required in the eligibility criteria.

7.	Additional Point		Printing of Sickle Cell status ID card is a specialized job and should be given to a medical company which is capable of doing screening and managing data. Therefore we request you to add screening experience in the eligibility criteria instead of printing experience.	<b>No Change</b> Also refer the additional clarification mentioned in Sl. No. 6
8.	Additional Point		Card data and the counseling data language should be mentioned and the details should be given in soft copy for printing.	<b>Clarification</b> It shall be provided to the selected bidder after signing of contract.
9.	Additional Point		QR code on the back side of card is very useful for online video counseling, blood bank and other related FAQs therefore a mobile application should also be in the scope of this RFP.	<b>Clarification</b> The QR code to be generated should be as per the applicable standard so that any available QR code scanner can read & retrieve the information. Hence no separate mobile application is required.
