However, free supply of drugs may be issued to the MHU by the respective District as per situational need, if required,
Nil	Kindly clarify if all the necessary Capex items – ICT, lab equipment, furniture – etc will be provided by the ZSS/CDMO?	<u>No change:</u> Clarification: Making provision of required equipment, furniture etc for the MHU to conduct health screening during camps is the responsibility of the Agency and the cost may be met from the administrative cost of the NGO under annual budget of the project.
Nil	Kindly clarify if vehicle has to be rented or procured for the purpose of fulfilling the program?	<u>No change:</u> Clarification: The Agency/service provider has to decide the mode of engagement of the vehicle to be used for MHU. However, under the annual budget for the project, monthly hiring and fuel cost has only been provisioned as fixed cost.
Nil	Kindly clarify if fuel bills and maintenance will have to be borne by the service provider or will be reimbursed by the ZSS/CDMO on actual ?	<u>No change:</u> Clarification: Under the annual budget for the project, monthly fuel cost @ Rs. 15,000/- has been provisioned as fixed cost. Maintenance of the vehicle is the responsibility of the Agency/service provider for which there is no separate cost provisioned.
