As per point no. vii of General information and instructions of the advertisement, "The candidate has to exhibit requisite documents / experience certificates which shall clearly establish his/her eligibility , without which his/her candidature shall be rejected. The experience certificate of the Employer/s must clearly specify the period of incumbency, name of the post and nature of responsibility" . 1- It is found that the post-qualification experience of M/s Annarpurna Agency from 12.02.2013 to 30.04.2015 is 02 years 02 months 19 days which is less than required 03 years of post-qualification experience. Further, 2- the appointment letter of ILFS Foundation Pvt. Ltd. could not be considered as post-qualification experience certificate. 3- the engagement letter of Centum Workskill India Ltd. could not be considered as post-qualification experience certificate and also the candidate has not submitted experience certificate of RCHS Khandapada from 01.12.2016 to 30.08.2025 at the time of submission of application form.
