The candidate has also not submitted the marksheet of MBA issued by the University, rather he had submitted net downloaded marksheet. The letter No.MITM/PRI/5052 Dated. 09.06.2025 issued from the Principal of the college can't be treated as pass certificate of University and the same can not be considered.</b></p> <p>Hence, in view of above points, the application is rejected as per the terms and conditions of the advertisement.</p>
